Therapeutic Area	Chronic Migraine
General Area of Interest	<p>Migraine is a neurological disorder characterized by recurrent episodes of headache that can be disabling, and chronic migraine occurs when a person experiences 15 or more headache days per month. Chronic migraine is a significant public health issue, affecting approximately 2% of the world's population, and often results in substantial disability, reduced productivity, and diminished QoL. Despite its prevalence, there is still a significant need for education among healthcare providers, caregivers, and patients for the understanding of the different aspects of management, patient care and clinical data of migraine.</p> <p>The main objective of this Request For Proposals is to prioritize education that will improve the knowledge and skills of healthcare providers in the areas of epidemiology, prevention, management and clinical data pertaining to migraine. Lundbeck will prioritize review of proposals that highlight:</p> <ul style="list-style-type: none"> • Epidemiology and prevention in migraine • Differentiation of primary headache disorders • Quality of Life: impact of migraine on QoL, improving QoL in patients with migraine • Managing medication overuse in migraine • Individualized care for patients with migraine: managing patient needs, shared decision-making • Prophylactic medications: single agent or combined therapies • Clinical Data on recently published data on migraine

	<p>Furthermore, the program will be educational and non-promotional in nature and will be planned, designed and implemented in accordance with the U.S. Food and Drug Administration's Guidance on Industry Supported Scientific and Educational Activities ("Policy Statement").</p> <p>The Policy Statement and the ACCME Standards require, among other things, that (i) Institution conduct the Program independently and without control or influence by Lundbeck over the Program's planning, content (including the selection of speakers or moderators), or execution; (ii) the Program be free of commercial bias for or against any product; (iii) Institution make meaningful disclosure of Lundbeck support of the Program and any prior relationship between Institution and Lundbeck, and the relationship, if any, between Lundbeck and the speakers selected by Institution; and (iv) Lundbeck not engage in, and Institution not permit any other sponsor to engage in, promotional activities in or near the Program room or advertise its products in any materials disseminated as part of the Program.</p> <p>In addition, Institution is required by the Policy Statement and the ACCME Standards to ensure that any product discussions at the Program be accurate, objective, balanced and scientifically rigorous.
